

<u>Product identification:</u> For each indicator, there are declared the highest result of the included products (i.e., the results of a "worst-case product", which may be results of one or several of the included products). The products are manufactured by the same company with the same major steps in the core processes.

FATRAFOL 803S (thickness 1,5 mm) AQUAPLAST 805GEO (thickness 1,5 mm) FATRAFOL 911 (thickness 1,5 mm)

#### Product description:

**FATRAFOL 803S** – is an unreinforced membrane on a base of plasticized polyvinylchloride (PVC-P). The membrane is identified first of all for clamped waterproofing of ground and underground buildings to aggressive, pressure and sucking water and as a waterproofing layer of waterproofing systems to leakage of liquids and leaches into the ground waters. The membrane is suitable for insulation of ground tanks, reservoirs, agricultural buildings, water constructions and dispose of industrial products.

**FATRAFOL 911** – is an unreinforced membrane on a base of plasticized polyvinylchloride (PVC-P) with a signal yellow layer. The membrane is intended for tunnels, constructed by tunnel boring machines, drill and blast method or cut and cover method and for underground structures being part of tunnels. It is designed for building structures loaded with water acting hydrostatic pressure.

**AQUAPLAST 805GEO** – is an unreinforced membrane on a base of plasticized polyvinylchloride (PVC-P). The membrane is stabilised against UV radiation and has a very good chemical resistance to all naturally occurring waters regardless of the amount of minerals and natural substances dissolved therein. The membrane serves for insulation of garden, ponds, fish ponds, biotopes and other water structures. The liner perfectly prevents from water loss through leakage, it has excellent dilatability, it can be adjusted to the base ruggedness and it is resistant to plant root penetration.

#### **Description of system boundaries:**

The system boundary is Cradle to gate with modules C1–C4 and module D according to EN 15804 + A2. It covers the production of raw materials, all relevant transport down to factory gate, manufacturing by Fatra, a.s. Czech Republic, transport of deconstructed materials, waste processing and disposal and recycling of used industrial doors. The review framework comprises the following details:

- Raw materials acquisition and transport,
- · Further processing of raw materials,
- Production operations,
- Energy and water consumption,
- · Waste management,
- · Packaging of the final product for delivery,
- Transport and waste processing,
- · Waste incineration with energy recovery, production of recyclable materials and waste disposal.




Figure 1 System boundary of the LCA study conducted on Fatra homogeneous waterproofing membranes

<u>Cut off rules:</u> The cut-off criterion was chosen based on the used PCR. According to the used PCR, more than 95 % of flows were included.

<u>Allocations:</u> As a general allocation rule the production of 1 m<sup>2</sup> of product was chosen. Common inputs (electricity, natural gas), material inputs, transport and common outputs (waste generated, emissions) are allocated to this product, i.e., to declared unit of this product.

#### Information about declared modules:

**Module A1** covers the production of materials for Fatra, a.s. and also it includes fuels and energy carriers (electricity, thermal energy). This consists of the production of input materials (PVC, additives etc.).

Module A2 covers the transport of material into the site of production Fatra, a.s.

**Module A3** covers on-site operated processes dealing with homogeneous waterproofing membranes production and packaging. Treatment and disposal of waste generated from the manufacturing processes is also included in this module.

**Module C1** does not cover estimated energy for deconstruction related to the mass of deconstructed material. In this case, it is assumed that energy spent for the deconstruction of 1 m² of homogeneous waterproofing membranes is negligible.

**Module C2** covers the transport of material into landfill plant and waste-to-energy plant.

**Module C3** covers processes of waste processing in waste-to-energy plant.

Module C4 covers processes of waste disposal in landfill plant.

**Module D** covers loads and benefits from energy recovery of materials from waste-to-energy plant. Electricity mix: DB process of Czech residual grid mix is used for production process in Fatra. The used

dataset has impact of 0,55 kg CO<sub>2</sub> eq./kWh for GWP-GHG indicator.

### Differences versus previous versions

In previous version of study different sets of indicators were used and only A1-A3 module were assessed. Updated generic process data for production of input materials were used. The updated PCR methodology was used.

In the revised version, the name AQUAPLAST 805 is changed to the new product name AQUAPLAST 805GEO. Also, biogenic carbon was balanced. Furthermore, information on the used energy mix was added. The specific data value was changed to <90%.
